## **Ongoing and Research Projects as Principal Investigator**

- **LEXIS (2024-2029)**

LEXIS focuses on citizen participation in the definition of laws. The objective of the project is to study the potential, modalities and effects of this participation on the evolution of democratic institutions. It is a broad project coordinated by the university of Montreal that involves 34 universities and 47 partners. I will be responsible of the working group on citizens assemblies in the context of sustainable development. **Total funding: 50.000 euro**

- **Smartwielen (2023-2024)**

Smartwielen is a questionnaire-based tool designed to help users compare their political views with those of candidates and parties participating in the national elections in Luxembourg. It has been launched for the first time in 2019 and has been implemented for national elections 2023 and European election 2024. Its implementation and coordinated is realized by the PDLP (University of Luxembourg) and the Zentrum fir Politesch Bildung

(ZPB). The project equally funded by the University of Luxembourg and the ZPB. **Total funding 100.000 euro**

- **Medialux. PI (2022-2027)**

The Medialux project at the University of Luxembourg aims to study and promote a diverse and sustainable media landscape in the country. The project involves an annual media survey, specific research projects on digital media, and public conferences on media and society. It is funded by the Ministry of State through two conventions. The first convention ran from 2022 until 2024 (250.000 euro) and the second convention runs from 2024 until 2027 (350.000 euro) The project is coordinated by Dr. Raphaël Kies and Dr. Stéphanie Lukasik (post-doc hired on the project). Total funding 500.000 euro.

- **Klima-Biergerrot (2022-2024)**

The Klima Biergerrot (KBR) is a citizens assemblies established in Luxembourg to facilitate public debate and engagement on climate change. The ministry of state established a convention with the university of Luxembourg to monitor its implementation and evaluate it. The project was followed by Raphael Kies (PI), Dr. Emilien Paulis (post-doc hired on the project), Lisa Verhasselt (PhD candidate hired on the project). **Total funding 300.000 euro.**

- **“Plateforme Luxembourgeois de la démocratie participative” (PLDP.lu) (2019-)**

The PLDP aims to promote participatory democracy in Luxembourg by establishing a national and international network around the challenges of participatory democracy. The platform focuses on knowledge dissemination, cooperation on participatory projects, and research and training. One of its main objectives is to support and evaluate the city of Dudelange, as Pioneer town in the domain of participatory democracy. The collaboration with the city of Dudelange started in December 2019 through two conventions so far. **Total funding: 500.000**

- **Media Pluralism Monitor (MPM) (2024-2027)**

The Media Pluralism Monitor (MPM) is a scientific tool developed by the Centre for Media Pluralism and Media Freedom (Florence) to assess the potential risks to media pluralism in European Union member states and candidate countries. It covers four major areas: fundamental protection, market plurality, political independence, and social inclusiveness, analyzing over 200 variables across these areas to provide a comprehensive overview of the state of media pluralism. Dr. Raphael Kies and Dr. Stéphanie Lukasik are responsible for the national country report of Luxembourg. **Total Funding: 32.000 euro**

- **Nexus (2023-2024)**

Country reports are to be compiled for the partner countries of the Common Ground Program, namely France, Belgium, the Netherlands, Luxembourg, Poland, the Czech Republic, and Switzerland.
