

MASTER EN ÉCONOMIE ET FINANCE QUANTITATIVES

Le Master en économie et finance quantitatives est un programme d'un an destiné aux étudiants à haut potentiel. Il introduit les étudiants aux méthodes et connaissances les plus avancées en économie, finance et analyse de données, et leur donne les moyens de développer de nouvelles méthodes et de repousser les frontières de la connaissance. Le programme les prépare à des carrières de haut niveau dans le monde académique, les institutions publiques et le privé. Pour les meilleurs étudiants, c'est une voie royale pour rejoindre l'École Doctorale d'Économie, de Finance et de Management de l'Université de Luxembourg.

FORCES

- Le programme correspond aux plus hauts standards internationaux. Il propose un niveau d'enseignement équivalent aux premières années des meilleurs programmes doctoraux anglo-saxons ;
- Au premier semestre, le programme se concentre sur les méthodes et connaissances fondamentales en économie et finance. L'approche est quantitative;
- Au second semestre, les étudiants sont exposés aux méthodes les plus récentes, et développent de nouvelles méthodes dans le cadre de leur thèse de Master. Les liens étroits avec les départements de recherche en économie et en finance garantissent une supervision individuelle par l'un des professeurs de la faculté ;
- Une bourse de mérite (partielle ou totale) est disponible pour une sélection d'étudiants.
